## REQUIREMENTS FOR EXEMPTION BENEFITS OF HOUSEHOLD AND PERSONAL EFFECTS

- **A.** THE DOMINICANS, WHO COME TO FINISH A DEFINITIVE RESIDENCE IN THE DOMINICAN REPUBLIC, AFTER THE RESIDENCE OF THE EXTERIOR FOR A PERIOD OF 2 YEARS OLD OR MORE
- **B.** THE DOMINICAN STUDENTS, WHICH HAVE BEEN PERFORMED AFTER THEIR STUDIES ABROAD FOR A PERIOD OF MORE THAN 2 YEARS.
- C. TO FOREIGNERS WHO HAVE OBTAINED PERMIT OF RESIDENCE IN THE DOMINICAN REPUBLIC
  - REQUIREMENTS FOR DOMINICANS WHO EMIGRATE TO THE EXTERIOR AND THAT ARE: RESIDENTS OR CITIZENS WITH DOUBLE NATIONALITY. (APPLY FROM 1 TO 08).
  - REQUIREMENTS FOR DOMINICAN STUDENTS, SUBMITTING THE TITLE, CERTIFICATE OR DIPLOMA OF THE UNIVERSITY STUDIES PERFORMED IN ORIGINAL AND A COPY. (ALSO THE REQUIREMENTS OF 2 TO 08).
  - REQUIREMENTS FOR FOREIGNERS, SEE GENERAL REQUIREMENTS FROM 2 TO 08.
    - 1. SUBMIT ORIGINAL RESIDENCE AND A COPY OF THE COUNTRY WHERE THEY LIVE, THE OR PASSPORT IF YOU ARE A CITIZEN, OR THE CERTIFICATION OF NATURALIZATION.
    - 2. PRESENT PASSPORT IN GOOD CONDITION, TO BE LEGIBLE AND WITH A MINIMUM OF 2 YEARS OF VALIDITY.
    - 3. COPY OF EXCELLENT QUALITY OF ALL PAGES OF OR PASSPORT AND 2 COPIES OF THE PAGE WHICH FIGURE PHOTOGRAPHY.
    - **4.** PRESENT KNOWLEDGE OF ORIGINAL SHIPPING (BILL OF LADING) ON BEHALF OF MOVING OWNER IMPORTED, MACHINE WRITTEN, SEALED BY THE COLLECTURE AND 3 COPIES. (WITH ACCURATE DATA).
    - 5. SUBMIT MOVE TAX SETTLEMENT SHET (PRINTER), SEALED AND SIGNED BY: VERIFIER, AUDITOR AND COLLECTURE. A COPY. (MAKE SURE THE DATA PROVIDED ARE THE CORRECT).
    - 6. PRESENTING THE ACCOUNTING RECEIPT SEALED AND SIGNED, CORRESPONDING TO THE RIGHT TO APPLY FOR PROCESSING. THIS RECEIPT IS OPENED IN RECEPTION AREA OF THE GENERAL DIRECTORATE OF CUSTOMS.
    - 7. FILL ONLINE (OR TYPING MACHINE) THE ADJUSTMENT FORM, PRINT, SIGN AND RETURN THREE (3) COPIES, VISITING <a href="https://www.dga.gov.do">www.dga.gov.do</a> "DE INTERES Y PUBLICACIONES / INTRUCTIVOS, ALSO <a href="https://www.aduanas.gob.do">www.aduanas.gob.do</a> NORMATIVA / FORMULARIO ELECTRONICO, OR REQUEST IT IN THE AREA OF RECEPTION OF THE GENERAL CUSTOMS ADMINISTRATION.
    - **8.** SUBMIT LETTER OF MARRIAGE OR OF ORIGINAL DIVORCE, UPDATED TO THE (RECENT) DATE. (DEPENDING ON YOUR CIVIL STATUS).

- SHIP YOUR CARGO AFTER BEING INFORMED BY CUSTOMS.

- CHECK THAT YOU HAVE ALL DOCUMENTS AT THE TIME OF THE APPLICATION PROCESS
- DO NOT BRING CHILDREN, TO PREVENT POSSIBLE INFECT CONTAGIOUS INFECT OR INFECTOCONTAGIOUS
  DISFASE.
- TRY NOT TO COME ACCOMPANIED, SO THAT YOU CAN GIVE A BETTER SERVICE AT THE TIME OF THE APPLICATION OF THE LAW.-
